HOLD HARMLESS AGREEMENT for SCCCE Cardboard Boat Race, June 19, 2025

1. I understand that boating and lake activities have inherent risks and dangers associated therewith, including but not limited to risks associated with perils of water and equipment failure and I specifically assume those risks.
2. I understand that due to the nature of boating and varying lake conditions, boating activities are not recommended for individuals who are pregnant or who have pre-existing physical conditions which could be aggravated by boating activities, and I specifically assert that I am free of such conditions. I will wear a life preserver and make sure that there are at least two persons in a canoe while we are on the lake, and no more persons than the number of seats in a canoe.
3. I understand that this property is an operating farm with dangerous livestock.
4. I understand that tree climbing or trespassing into livestock areas and playing around dangerous farm equipment is strictly prohibited. If injury or death occurs from engaging in those prohibited activities, I assume that risk and agree to pay damages should equipment or animals be harmed.
5. I understand that livestock are enclosed in high joule electric fences and physical barriers and that if I touch an electrified fence physical harm could occur to me.
6. I understand and agree to close physical barriers (gates) to keep livestock in their confined space. If physical barriers (gates) are left open by me, or minors under my supervision, I agree to pay damages for my negligence, to include damages to third parties, should animals make their way to public roads.
7. I understand that the bottom of the lake is full of moss and mud and is hazardous. Swimming is allowed only with adult supervision. I understand that there is no lifeguard, and swimming will be at our own risk.
8. I understand that the Rope Swing is OFF LIMITS.

9. I understand that swimming or boating under the influence of any alcohol is strictly prohibited.
10. I fully understand that if medical conditions arise and help is needed, the nearest hospital is 20 – 30 minutes away and medical help will be delayed until they can be notified and transport me to a medical facility.
11. It is my specific intention by this instrument to exempt and relieve Suus Donum Enterprises, Inc. and Buttercup Ranch & Creamery associates and their officers, agents, operators, and employees, from any and all liability for personal injury, property damage or wrongful death caused by negligence or otherwise, and I assume all risk in connection with such property and lake activities.
12. Suus Donum Enterprises, Inc. and Buttercup Ranch & Creamery have made no representation to me, implied or otherwise, that they or their representatives or employees will perform safe rescues or render first aid. In the event I show signs of distress or call for aid, I would like assistance and will not hold Suus Donum Enterprises, Inc. or Buttercup Ranch & Creamery, its vessels or agents responsible for their actions in attempting the performance of a rescue or first aid.
